In continuation of our letter dated March 23, 2020, March 31, 2020, April 14, 2020, April 15, 2020 and pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that taking cognizance of the orders of the Government dated May 01, 2020 for the extension of lockdown as per zone wise in the Country till May 17, 2020 or any further such orders/directions amid spread of COVID – 19 Pandemic, and in accordance of the relaxations given by the respective local administration, operations at our following ongoing Work Sites are allowed to work in strict compliance to National Directives for COVID-19 Management and Standard Operating Procedure for Social Distancing:
